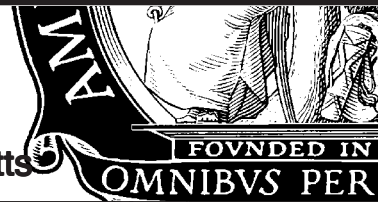

# MASSACHUSETTS CHAPTER OF THE AMERICAN COLLEGE OF SURGEONS

## Highlights of the 2007 ANNUAL BUSINESS MEETING

Saturday, December 8, 2007 / Boston, Massachusetts

### REPORT OF THE PRESIDENT

Dr. McAneny congratulated Dr. Terry Buchmiller, Scientific Program Committee Chair, for coordinating another successful educational program which incorporated a number of distinguished guest speakers this year.

Dr. McAneny gave special acknowledgement of two Massachusetts surgeons who were recently honored at the Commission on Cancer Annual Meeting in New Orleans, Louisiana, during the American College of Surgeons Clinical Congress. Peter Hopewood, MD, FACS (Falmouth Hospital, Falmouth MA) and R. Leslie Shelton, Jr, MD, FACS (Health Alliance Hospitals, Leominster MA) were among the 57 physicians recognized nationwide with Cancer Liaison Physician Outstanding Performance Awards for 2006. Dr. McAneny noted this as quite an accomplishment, considering that there are over 1,600 CLPs working on behalf of the CoC. Dr. McAneny also congratulated Dr. Andrew Warshaw on receiving the 2007 Arthur Ellenberger Award, for excellence in State Advocacy, at the Board of Governors meeting at the Clinical Congress in New Orleans.

Dr. McAneny reminded the Members present that, although the Council officers regularly participate at the Spring Leadership Conference in Washington DC, they should notify him or the other Council Members if they are interested in being a candidate for the 2008 Leadership Conference, especially if they are a younger surgeon.

At the conclusion of his remarks, Dr. McAneny paid special recognition to Dr. Gerald Healy, current President of the American College of Surgeons, for his accomplishments and presented him with a commemorative plaque. Dr. McAneny positioned him as an example of how Chapter participation can ultimately lead to greater roles in the national organization.

### REPORT OF THE CHAIRMAN OF THE ACS BOARD OF REGENTS

Dr. McAneny called upon Dr. Josef Fischer, Chair of the ACS Board of Regents, for updates from the American College of Surgeons. Dr. Fischer shared feedback that centered on socio-economic issues and other concerns presently facing the College.

Dr. Marc Rubin, Secretary, requested a motion to approve the Minutes of the Annual Business Meeting of Saturday, November 17, 2006 and presented Membership Statistics, as of November 2007:

Dr. Rubin further noted that there are 633 Fellows of the ACS who are currently not members of the Massachusetts Chapter.

### REPORT OF THE TREASURER

Total Assets for the year as of October 31, 2007 were \$150,305. Total receipts as of the end of October were \$72,667, and total disbursements were \$50,142, making for an operating surplus of \$26,471 prior to the expenses of the 2007 Annual Meeting being realized.
